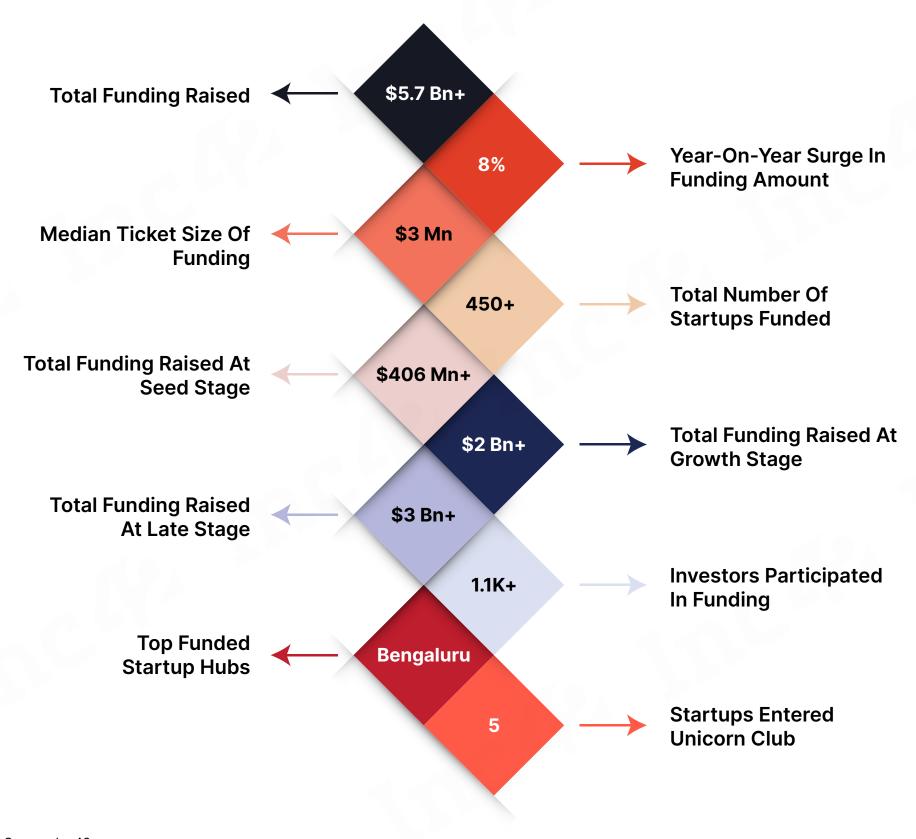

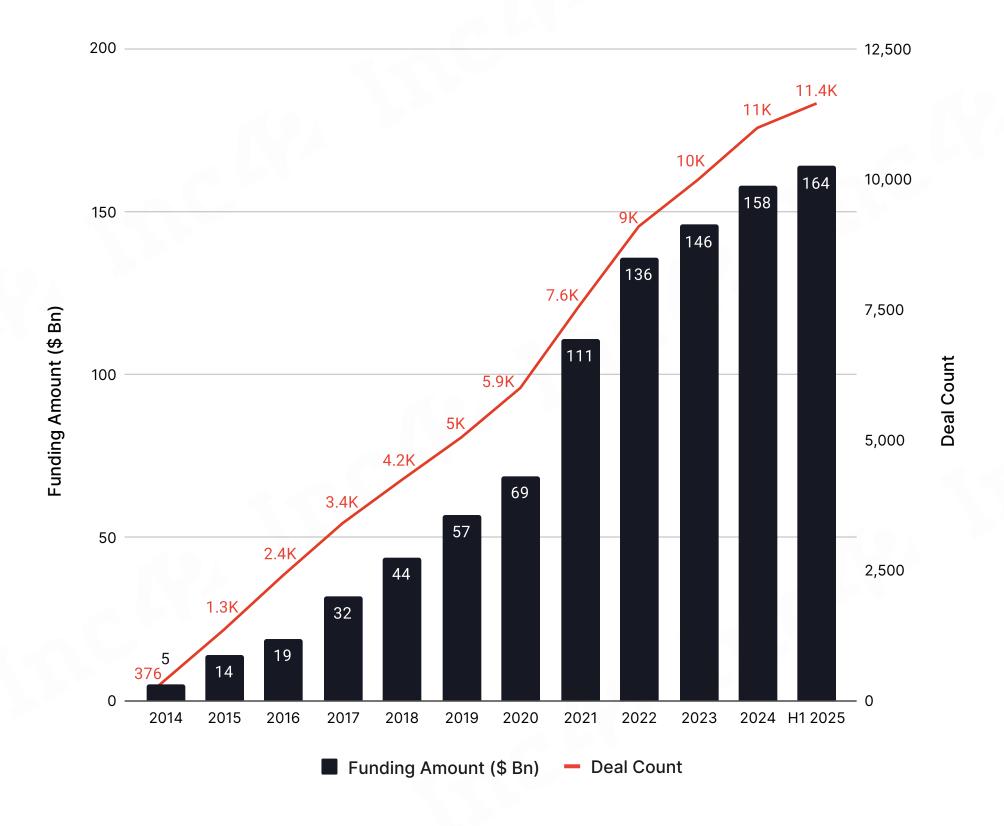

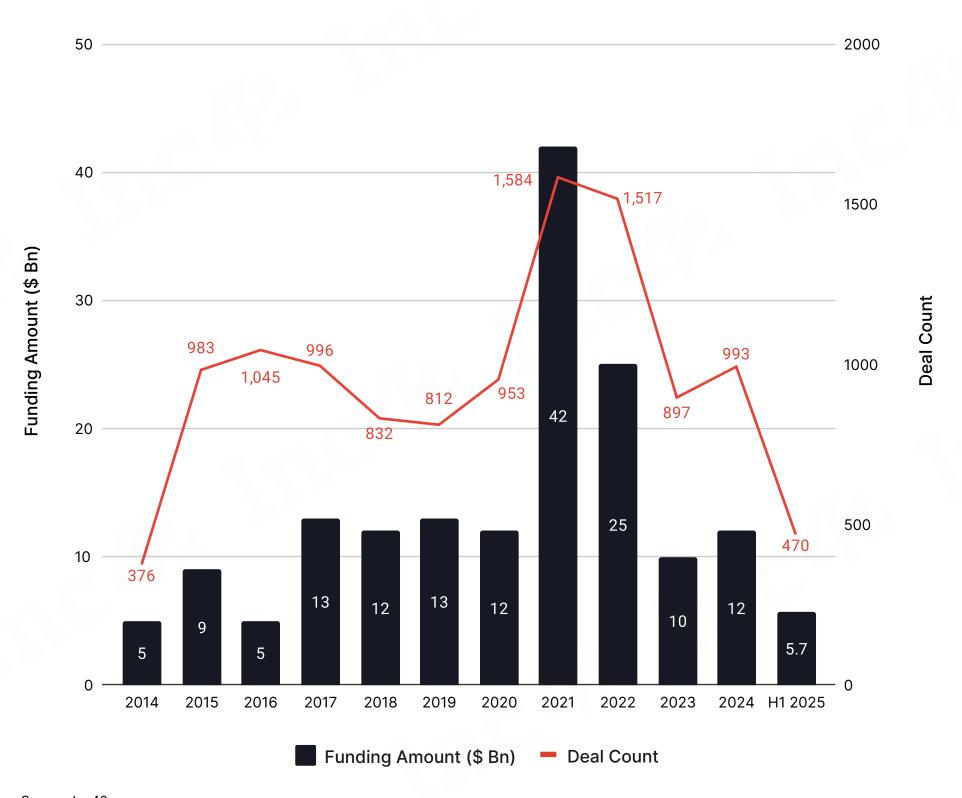
Indian Startups Cross \$164 Bn+ In Total Funding

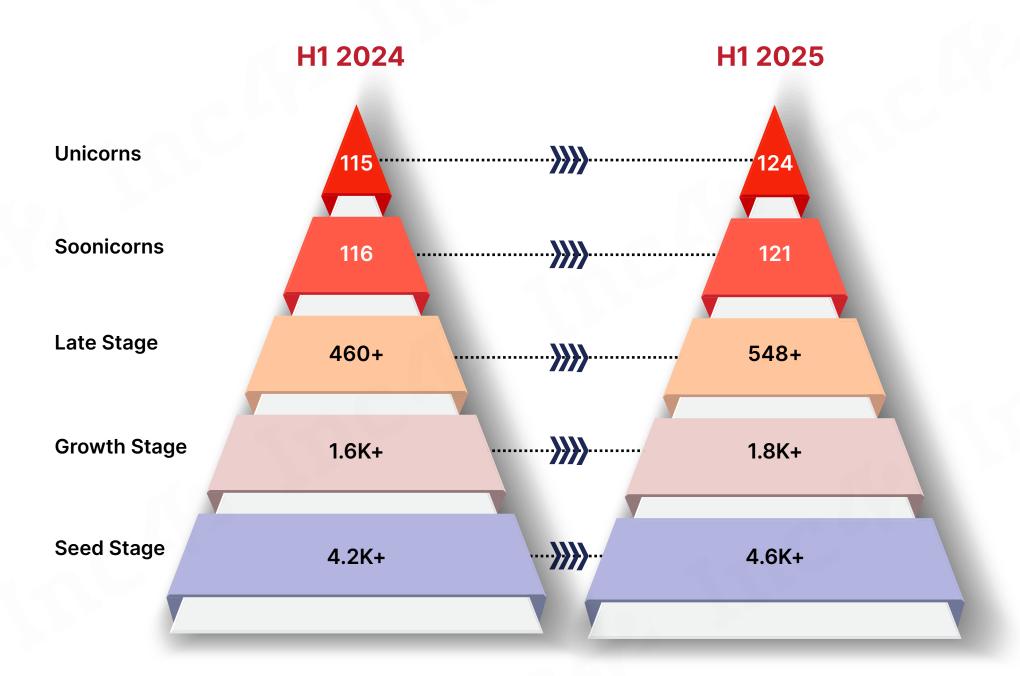

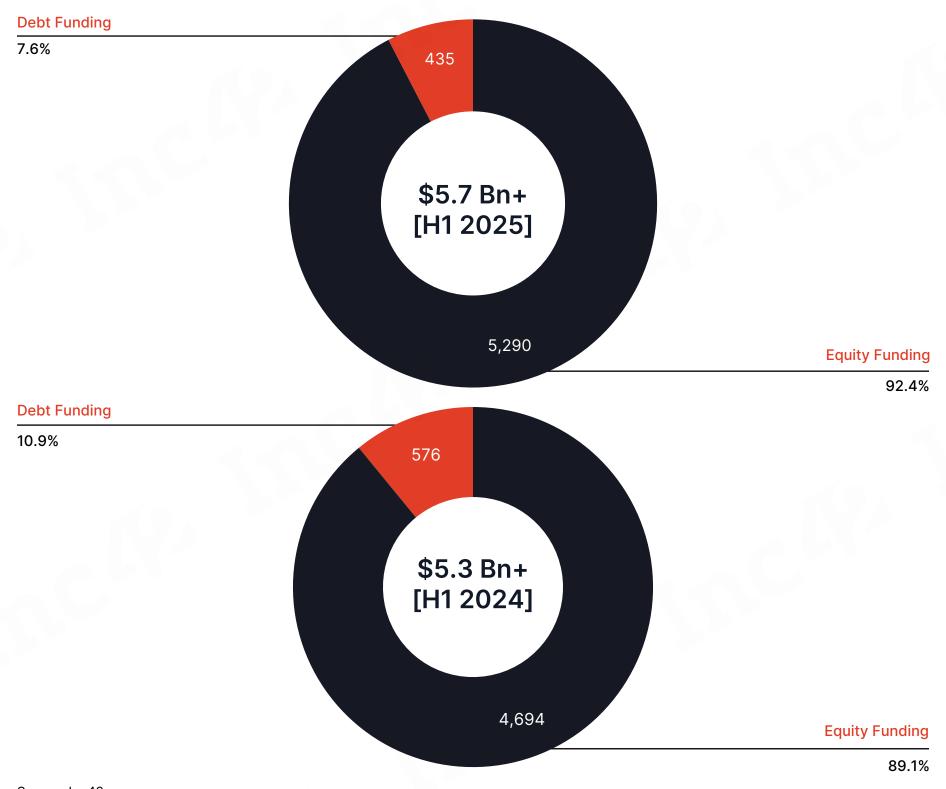

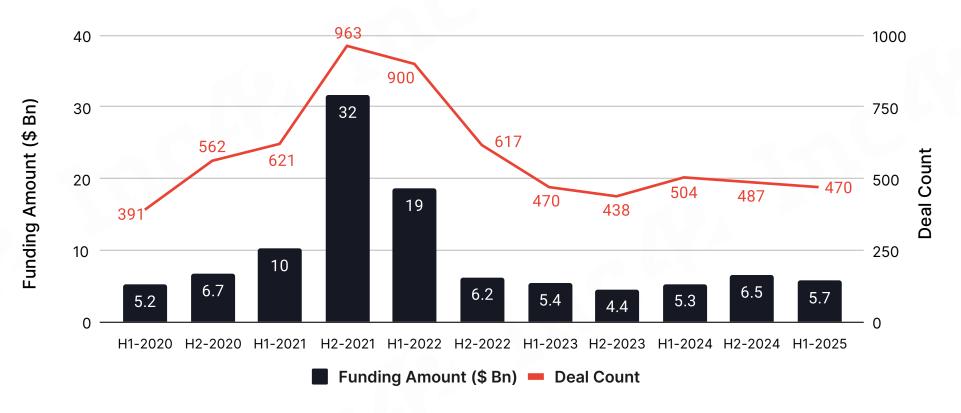


Debt Vs Equity: A Closer Look At Startup Capital Mix In H1 2025

Indian Startup Ecosystem On Track To Amass Up To \$14 Bn By The End Of 2025

Inc42's 2024 report projected \$5.8 Bn in H1 2025 funding under normal conditions. With actuals at \$5.7 Bn - just 1.8% off - full-year funding is now projected to reach \$14 Bn - \$15 Bn

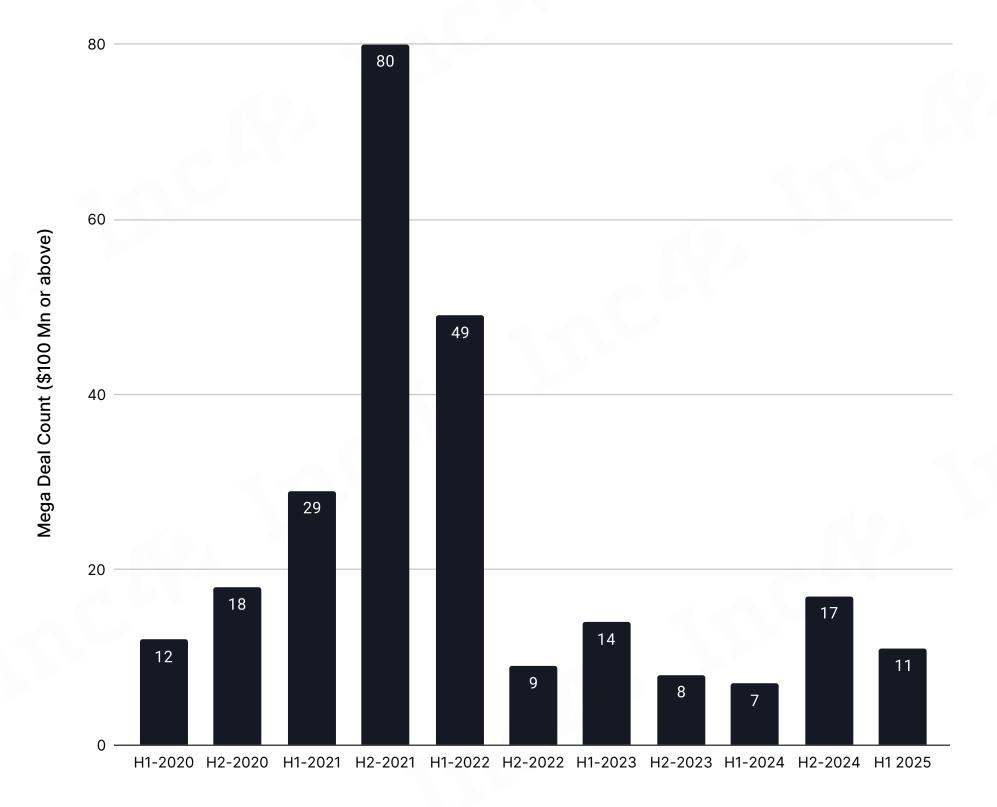

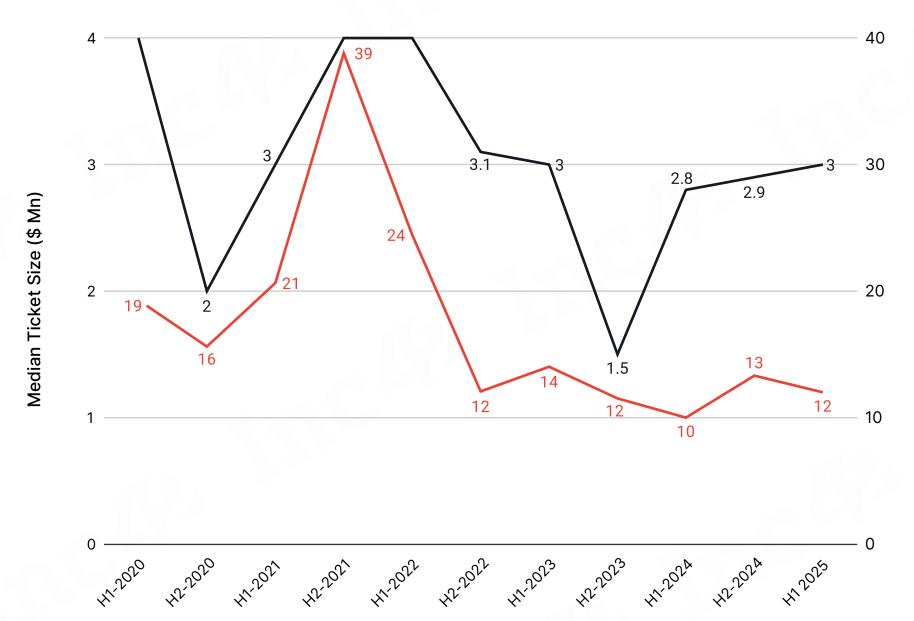
Mega Deals Surge 57% In H1 2025

Median Ticket Size (\$ Mn) — Average Ticket Size (\$ Mn)

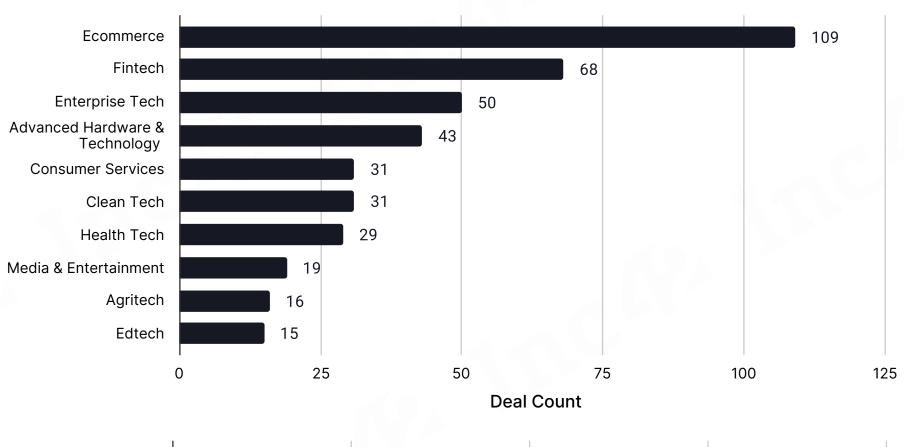

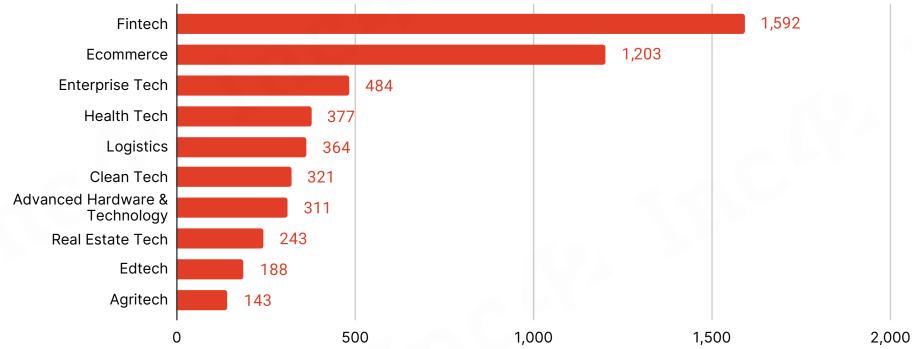

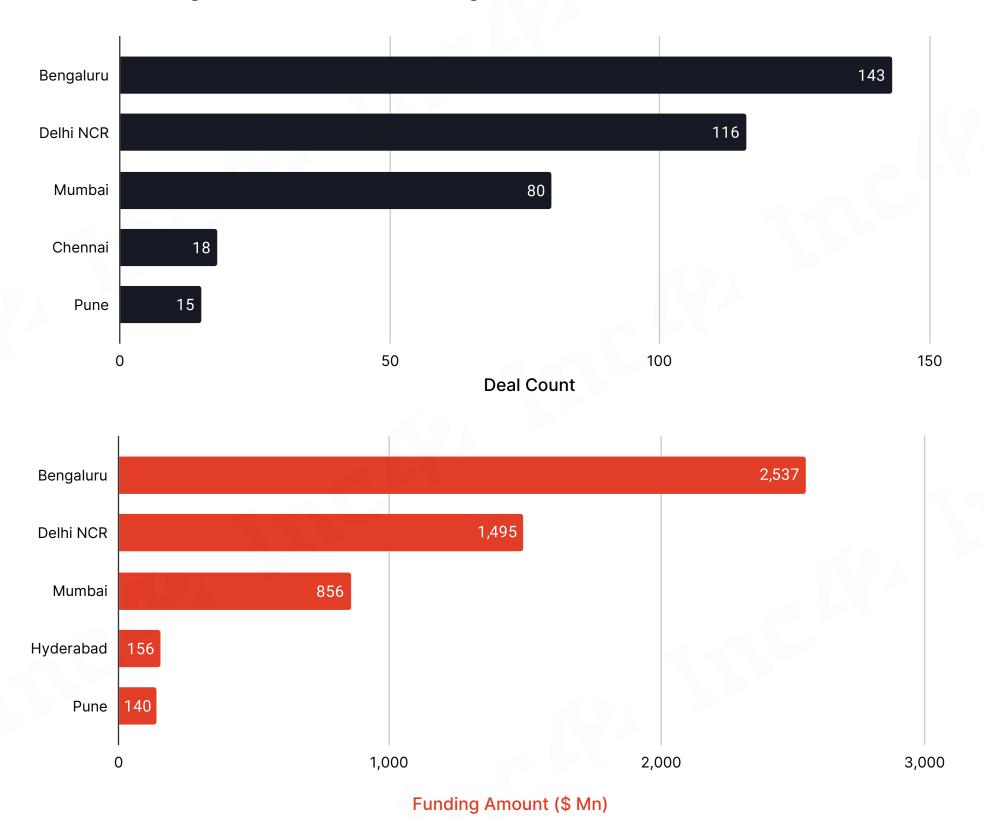

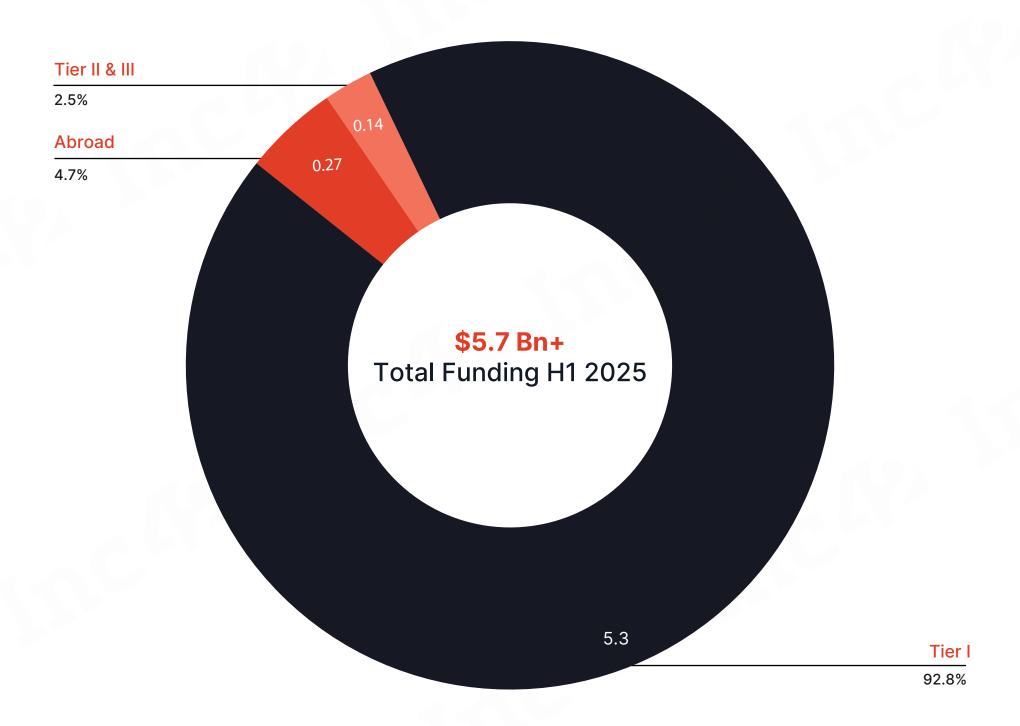
India's Top Funded Startup Hubs [H1 2025]

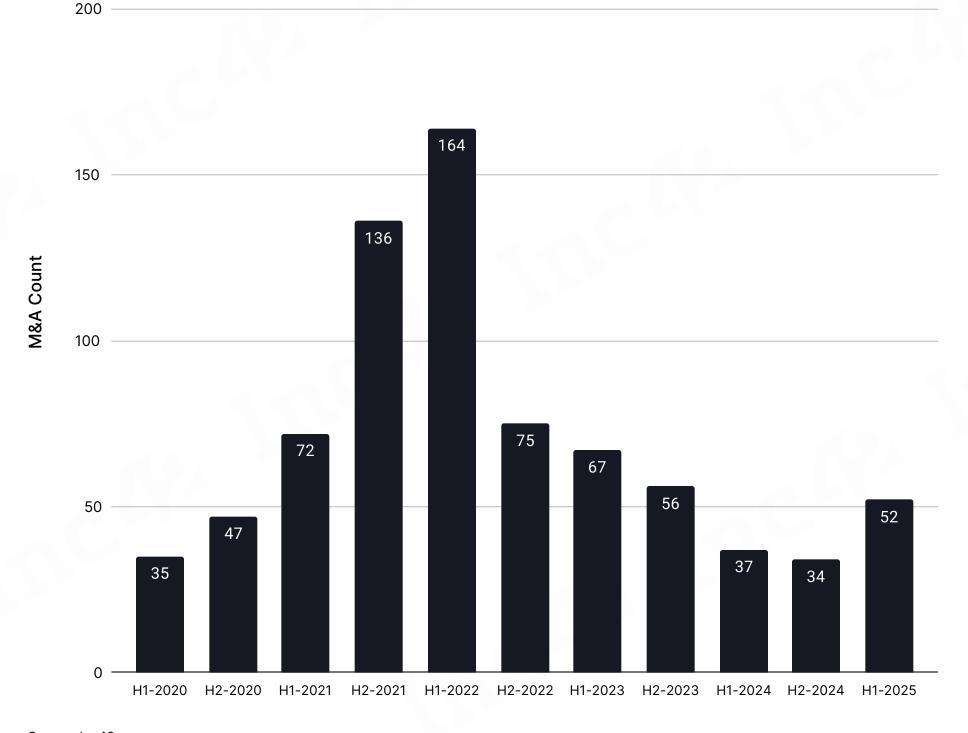

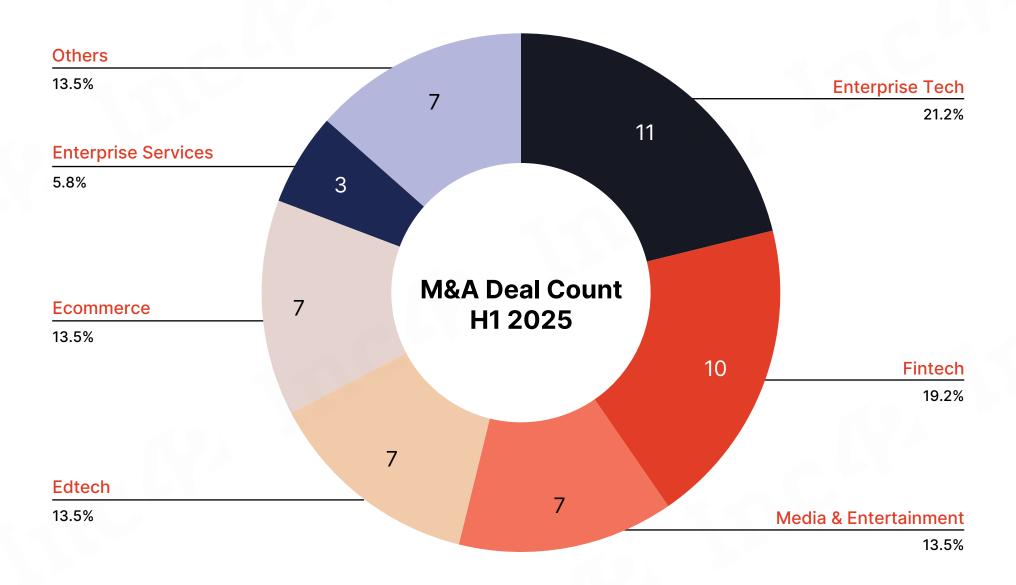

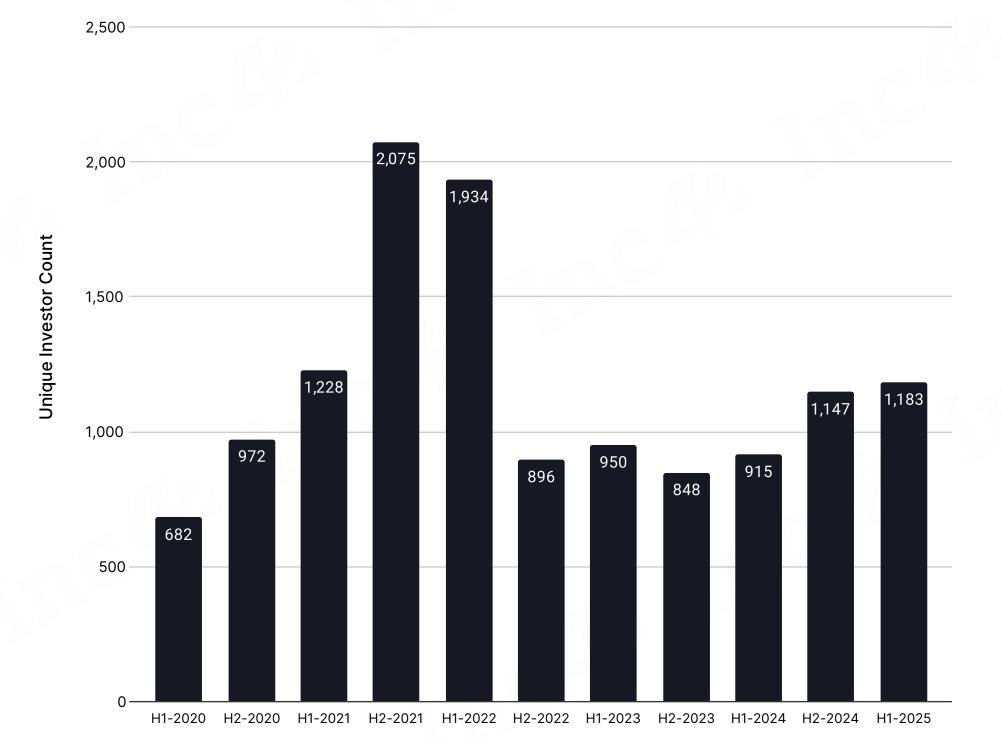

Key Signals To Watch Out For In H2 2025

Al To Remain Investor Favorite: Despite the implementation of global GPU procurement and supply restrictions by the United States in early 2025, investor appetite for the Indian Al startups continues to demonstrate resilience. Our most recent investor survey indicates that Al emerged as the predominant sector preference for both early stage and growth stage investments in the latter half of 2025.

Higher Capital Inflow In H2 2025 Than H1: According to Inc42 estimates, Indian startup funding for 2025 is anticipated to reach \$14-15 Bn, with the second half contributing 57-59% of total capital deployment. Current performance indicators align with our baseline projections, and we forecast this trajectory to persist through the remainder of the year under prevailing market conditions.

Demand For Hardware Startups To Rise: Indian hardware startups have historically struggled to attract venture funding, receiving only \$1.1 Bn (under 1% of total \$164 Bn) from 2014 to H1 2025. However, H1 2025 saw a notable surge with \$311 Mn invested—nearly one-third of the cumulative total. This momentum is reflected in our investor survey, where hardware emerged as the second-preferred growth-stage sector for H2 2025.

Investor Interest To Rise In Defence Tech: Against the backdrop of Operation Sindoor and rising global demand for sovereign defence technology, investor interest in defence tech startups is expected to accelerate. Priority segments include defence drones, counter-drone systems, and satellite imagery solutions. The performance of listed Indian drone and defence companies, coupled with Raphe mPhibr's \$100 Mn funding round, signals strengthening investor confidence in this sector.

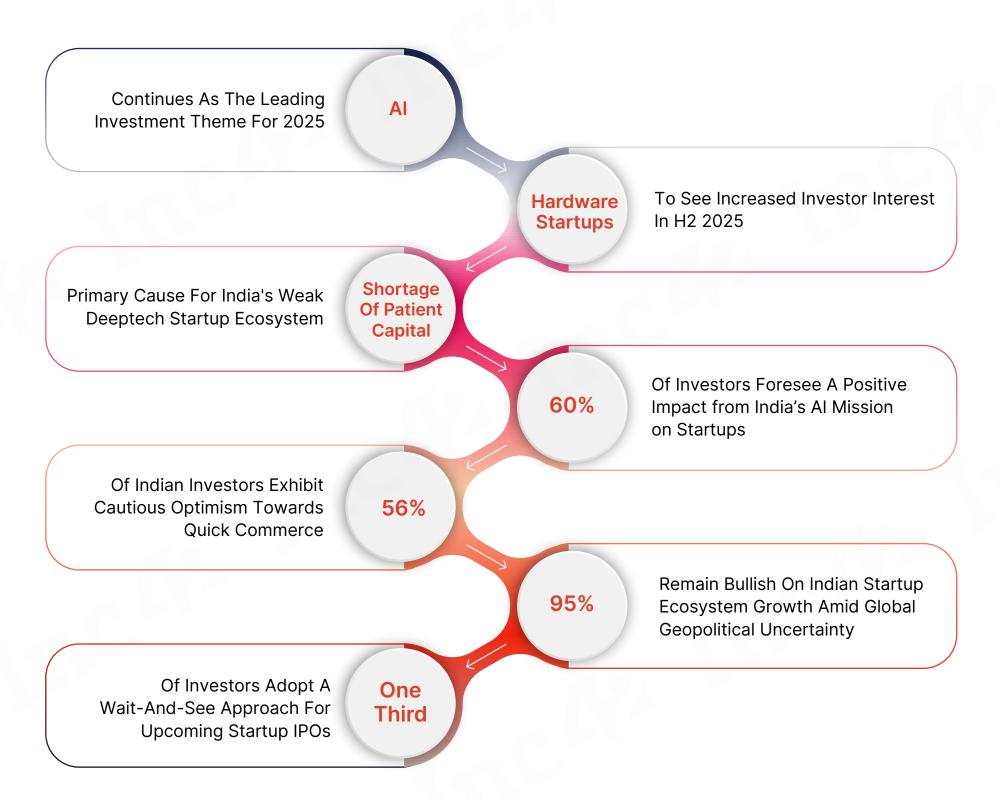

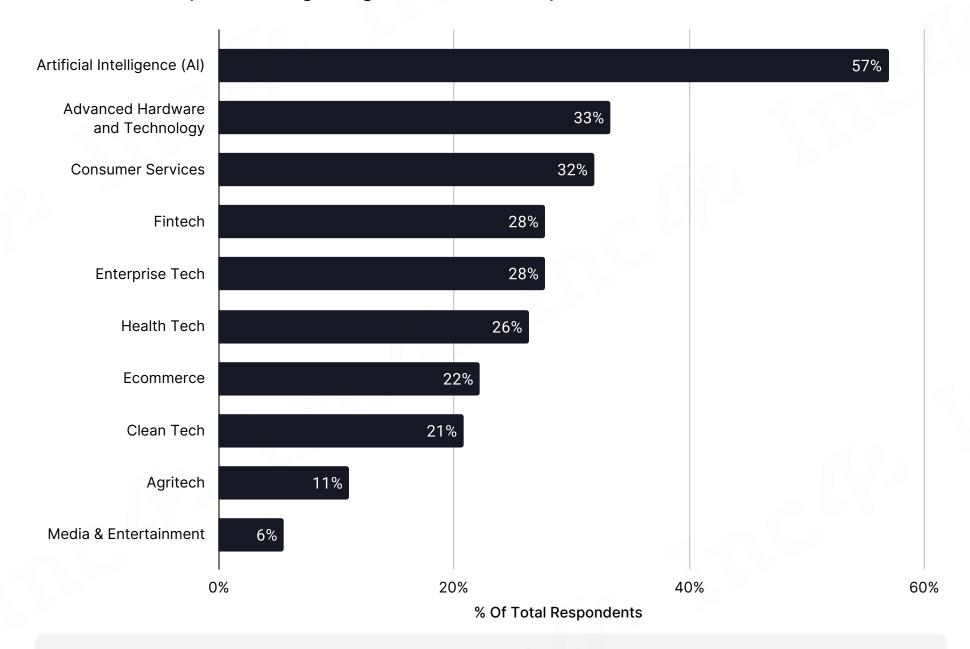

As seen in Inc42's 2024 survey, Al continues to lead investor interest at the early stage, while hardware startups are also gaining momentum after years of limited attention



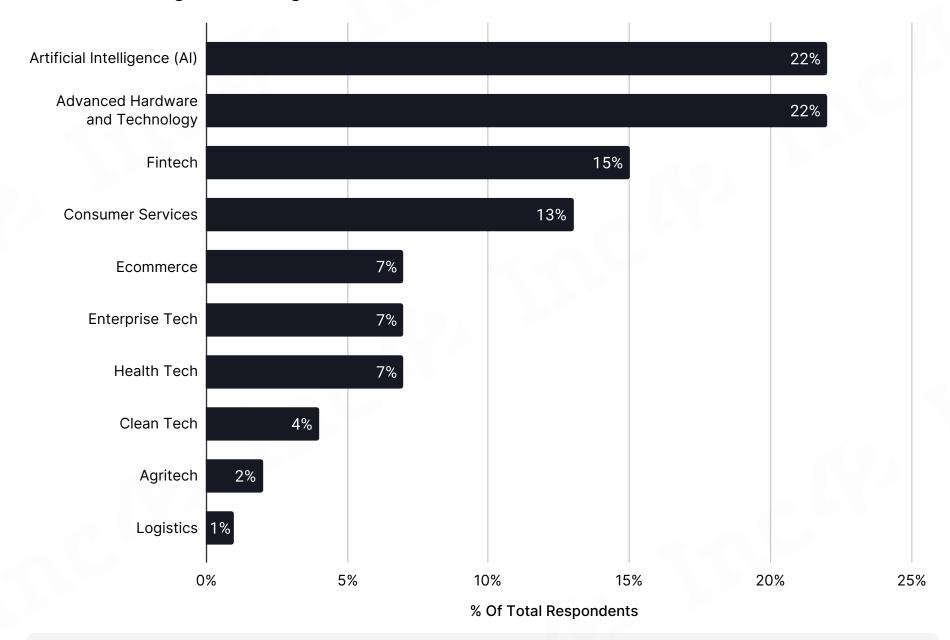
Question Asked: Which of the following sectors are you looking to invest in at an early stage in the second half of 2025?

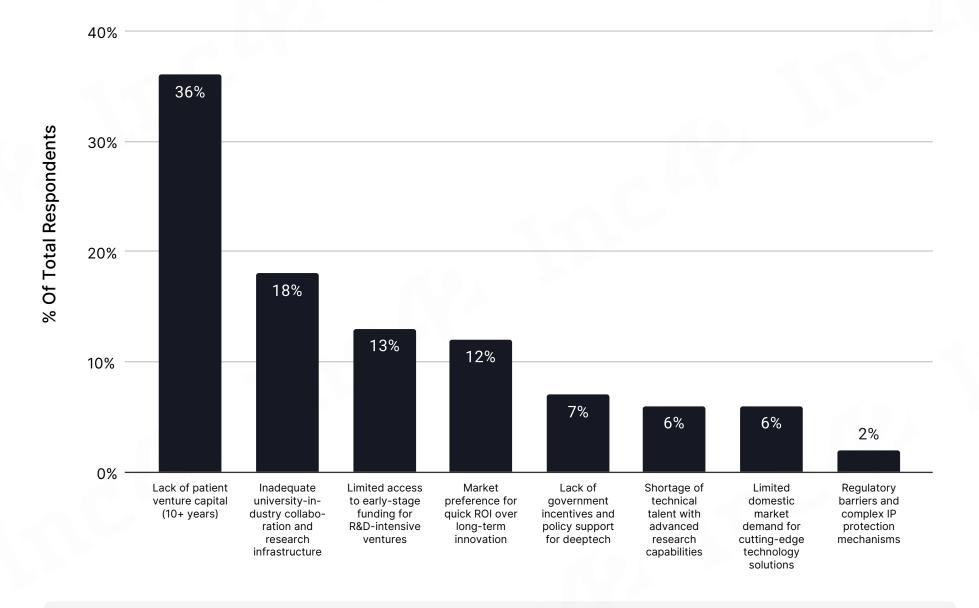


Question Asked: Which of the following sectors are you looking to invest in at growth stage in the second half of 2025?

Lack of Patient Capital Stalling India's Deeptech Ambitions

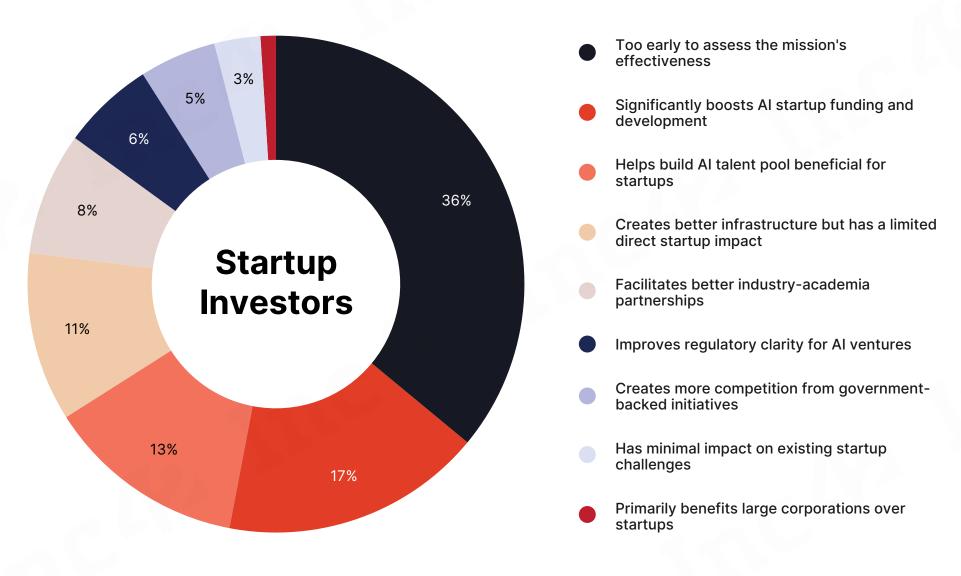

India Al Mission Wins Early Confidence From Startup Investors

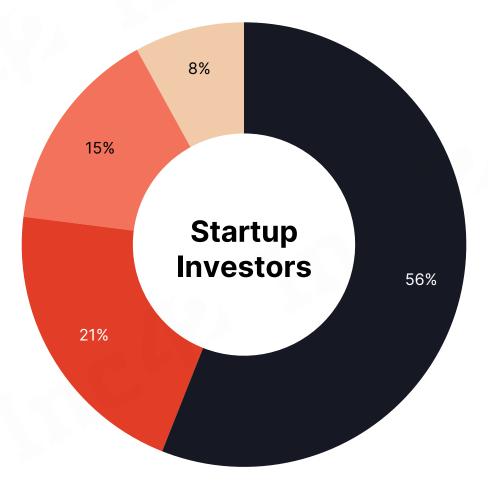
Despite being in its early stages, most investors expect the India Al Mission to positively impact the country's deeptech ecosystem, with only 4% anticipating minimal or no effect

While 56% see long-term potential, 21% remain concerned about burn rates and the lack of a clear profitability path.

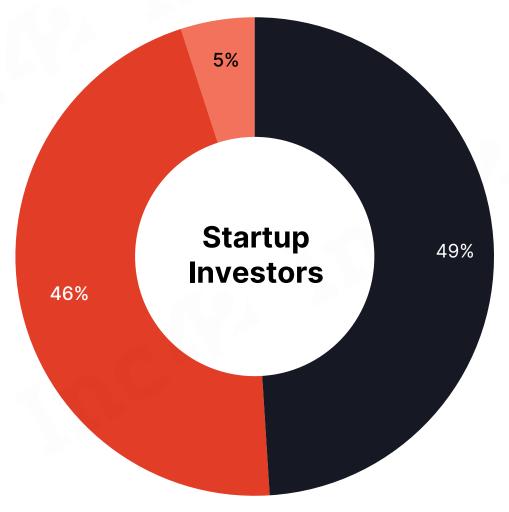

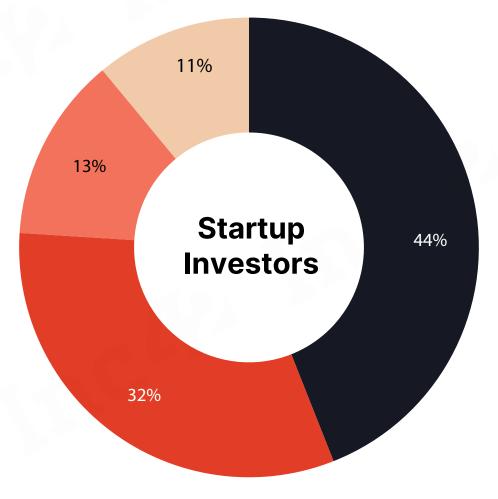

- Selective Bullish only on a few sectors or IPOs
- Sceptical Valuations still seem frothy, not seeing clear retail appetite

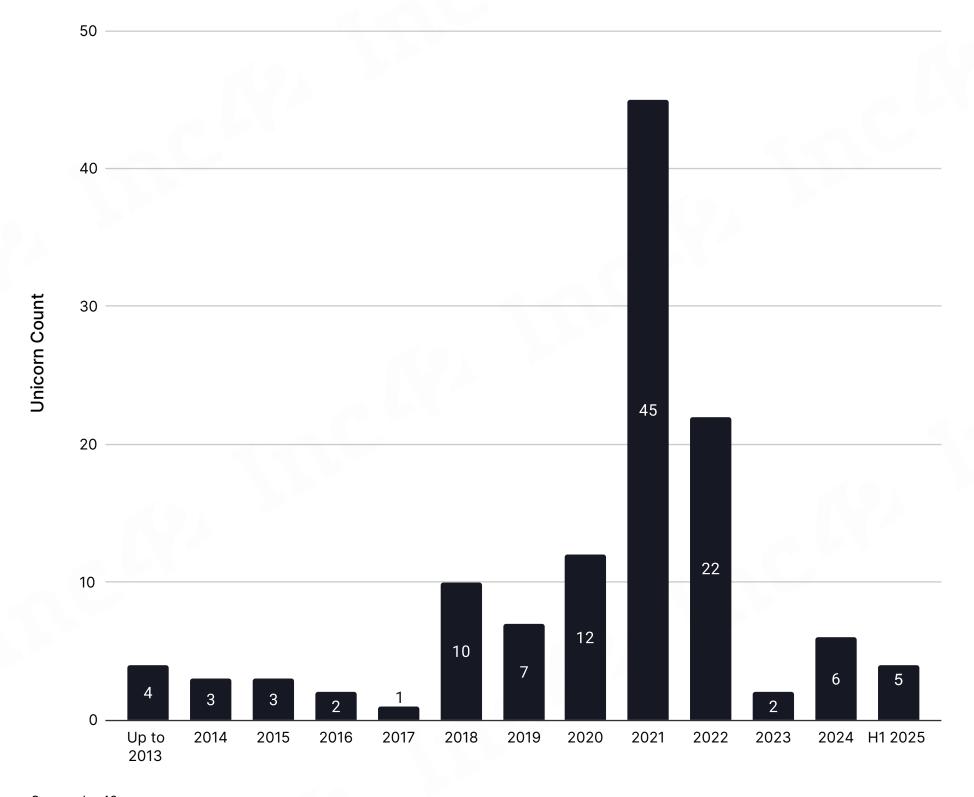

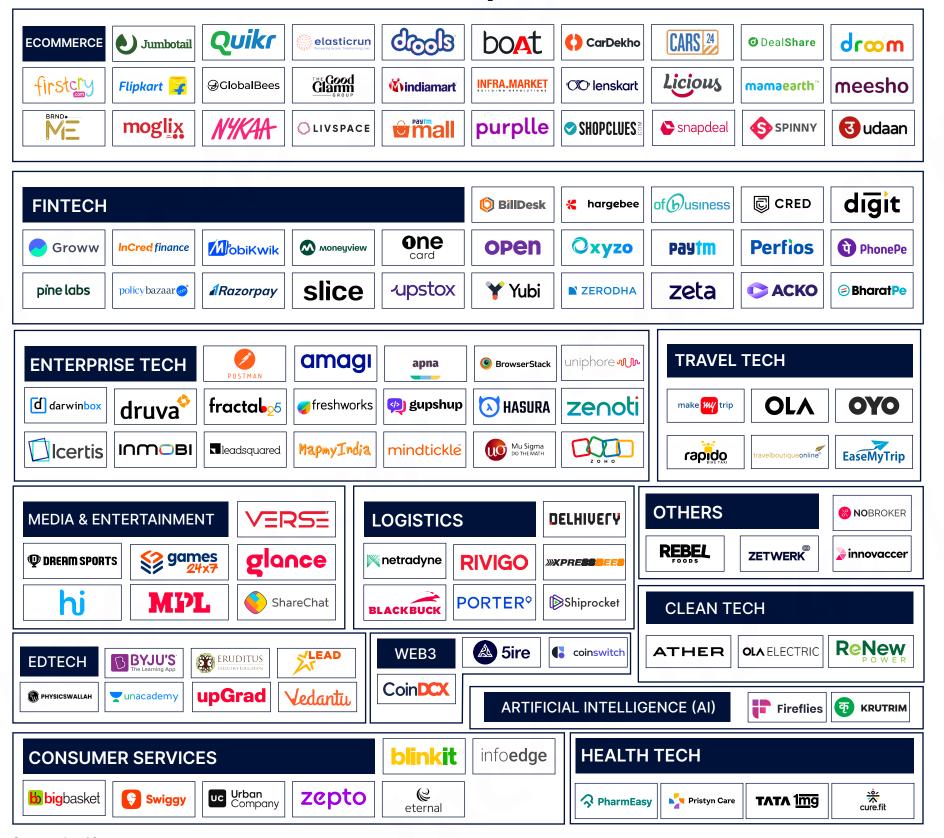
