








## Indian Startups Go For Debt: Share Of Debt Funding In Total Investments Doubles In H1 2024

D2C brands and lending tech startups were the most funded sub-sectors in ecommerce and fintech, respectively








#### Indian Startup Funding: Mega Deals Plummet 50% In H1 2024















#### The M&As Slow Down: Indian Startup M&As Return To 2020 Levels In H1 2024










## Women-Led Startups In India: Ecommerce & Fintech Received Highest Funding In H1 2024


#### Women Led Indian Startups: Delhi NCR Stood As The Top Hub In H1 2024


#### Milestone Alert: India's Startup Funding Soars Beyond \$150 Bn

## Indian Startups' Unstoppable Momentum: \$50 Bn In 5 Years, \$100 Bn In Another Five





#### The Indian Unicorn & Soonicorn Landscape










## Fintech Reigns Supreme: Investors Flock to Sector, Over GenAl In H1 2024




Bullish Outlook For Indian Startups In 2024: 93% Of Investors Foresee A Year Of Recovery


